**Terms of Agreement:**

1. Fun Time Photobooth Rentals will arrive at event venue approximately one hour before scheduled rental start time to setup equipment and make sure that everything is operational.

2. It is the sole responsibility of the client to secure permission of the event venue for Fun Time Photobooth Rentals to setup and operate the Photo Booth at this event. The Photo Booth requires approximately 10ft by 10ft space, and requires access to a 120-volt electrical outlet. The client is responsible to inform Fun Time Photobooth Rentals of any restrictions at the site that may affect the setup or operation of the Photo Booth and/or Fun Time Photobooth Rentals ability to adequately perform their duties. The client understands that such restrictions may adversely affect the overall experience and/or quality of photos, and that Fun Time Photobooth Rentals is not responsible for the consequences of such restrictions.
3. Fun Time Photobooth Rentals takes the utmost care regarding equipment function, photo quality, and printing. However, due to the nature of technology, some downtime may occur. Fun Time Photobooth Rentals guarantees its equipment to be operational at least 80% of the scheduled rental time, and will refund a pro-rated amount of the rental price for any downtime beyond this caused by equipment malfunction.
4. In the event Fun Time Photobooth Rentals fails to comply with the terms of this agreement, Fun Time Photobooth Rentals will only be liable for funds received.
5. Client agrees to indemnify Fun Time Photobooth Rentals against any and all liability from any claims, actions, suits, costs, damages or liabilities including but not limited to liability for personal injury of any person at the event, and/or property damage.
6. Client acknowledges that it shall be responsible for any damage or loss to the Provider's Equipment caused by any misuse of the Provider's Equipment by Client or its guest.
7. Minors (under 18) may not operate the photobooth unless accompanied by parent/guardian over the age of 18.
8. Fun Time Photobooth Rentals reserves all rights to the photographs captured during event and may use for demonstration, publication, and/or other purposes. Original media and copyrights remain the exclusive property of Fun Time Photobooth Rentals.
9. Any individual aspects or particular requests should be made prior to your signing this agreement.

10. This agreement incorporates the entire understanding of the parties. Any modifications of this agreement must be in writing and signed by both parties.
11. This agreement shall be governed by the law of the state of California.
12. Payments shall be due at the following times: 50% initial deposit; the balance is due 30 days before the event date.
13. If event is cancelled more than 30 days prior to scheduled event date, the client will forfeit the non-refundable deposit. However, this deposit may be applied with no penalties to a later available date agreed upon by Fun Time Photobooth Rentals representative and the client within 60 days of cancellation date. If no later date is available, the deposit is forfeited to Fun Time Photobooth Rentals.
14. If event is cancelled within 30 days of scheduled event date, 50% of full rental price will be forfeited by client.
15. If event is cancelled within 7 days of scheduled event date, 100% of rental price will be forfeited by client.
16. If Fun Time Photobooth Rentals cancels the contract due to illness or a non-compliant Client (Client violates any terms of the Contract, Fun Time Photo booth Rentals may refund all or a portion of the fees already received. Any fees paid for services/products already completed will not be refunded.
17. A 50% non-refundable deposit is required to reserve your event date. Final payment is due 30 days prior to event.
18. Any failure to make timely payments may result in cancellation of this contract. Fun Time Photobooth Rentals will make every attempt to provide notice to Client before cancellation occurs.
19. Please note that you may be required to book for more than 2 hours and a travel fee may apply based on your event date or location.
20. We accept Visa, MasterCard, American Express, or Discover. Processing fees may apply. Other acceptable forms of payment are check, Venmo and Zelle.
